#### (I) **COMPANY PROFILE:**

**India Ports Global Chabahar Free Zone**" (IPGCFZ), Indian SPV at Chabahar was incorporated in Iran in June 2018. IPGCFZ commenced its first cargo operation in Iran on 30th December 2018. IPGCFZ is subsidiary wholly owned by India Ports Global Limited, Mumbai, under the administrative control of Ministry of Ports, Shipping & Waterways (Government of India).

#### (II) The details with regards to aforementioned post is as follows:

#### General Manager (Port Operations) - IPGCFZ - 1 post

#### i. Details of Qualification & Experience:

Educational/Professional Qualification

Degree from recognised university of India

#### Experience:

- (i) At least 20 years in Port Operations with thorough knowledge of Port Management.
- (ii) 10 years' experience should be at middle Management level of Port Operation Company.

Candidate will be reporting to MD, IPGCFZ and MD, IPGL.

- ii. Age: Below 55 years.
- iii. Terms of engagement: The engagement will be on contract basis.
- **iv. Period of Contract:** The candidate will be engaged on contract for a period of 2 years. The period of contract may be further extended for a period for a period of one year at a time, up to further 3 years (i.e. total 5 years), at the discretion of organisation.
- **v.** <u>Location of Work:</u> The location of work will be at Chabahar; Iran However, your services will be liable to be transferred to any other place, in India or abroad, at present or future offices, assets, units, establishments (including those of partners, associates,

business alliances, joint ventures, subsidiaries), at the absolute discretion of the Appointing Authority.

#### vi. Roles and Responsibilities:

- (i) Establish standard operating procedure for Jetty, Yard and other areas as per international practice.
- (ii)Close coordination with the planning & Yard manager thereby ensuring effective vessel management.
- (iii)Ensure availability of all resources to maximize the productivity of berths.
- (iv)Coordinate with the vessel superintendent and ensure that the plans/documents essential for the daily vessel operations are available, if not take up the matter with the respective departmental heads
- (v)Ensure coordination with Stevedore/Subcontractor if applicable and smooth operation
- (vi)Establish, organize, and maintain a high standard of working relationships with the terminal/port stakeholders, lines, agents, shippers, consignees, port authorities, customs, and other concerned parties.
- (vii)Analysis Monitor and analyze the following factors on a regular basis- Quay crane productivity and utilization, Utilization of all quayside resources, Number of vessels serviced per day, the Completion time of vessels, Berth occupancy, and vessel waiting time before commencement
- (viii)He/She will be responsible for planning, administering and reviewing the operations in order to optimize resource use, minimize costs and maintain quality standards. He/She will also ensure safety and health throughout the terminal, including the proper handling of dangerous goods.
- (ix)Ensure the liner agent and marine operations are timely informed about berthing/sailing time,improve productivity.
- (x)Devise ways and means to efficiently utilize critical resources like Power, Water, equipment maintenance and other admin expenses to bring down the bottom line.
- (xi)Ensure Daily report and Monthly report to Top Management
- (xii)Overall administration of operation, report incident to HOD and corrective action on same.
- (xiii)He/She will ensure IMO regulations are complied with.

#### vii. Remuneration and Accommodation:

- (i) As per Industry Standards (The remuneration will be decided by the organisation as per the suitability, experience of the candidate in the remuneration range as mentioned above) + accommodation and transport.
- (ii) The charges of utilities in the accommodation provided will be incurred by the organisation.
- (iii) Travel allowance/Daily allowance will be provided for preapproved Tour Programmes as per the Actuals for Economy Class (Air Travel) subject to approval of the Competent Authority.
- (iv) Applicable Iranian Income Tax on the remuneration will be borne by IPGCFZ.
