Corrigendum – I

The Pre-proposal meeting was held on 15th February 2024 at 11:00 AM. Thereafter, four consultancy firms namely Deloitte, TPF Engineering, CRISIL and KPMG submitted their queries. SDCL management has deliberated on the queries submitted and decided to amend some clauses as mentioned below:
